The Institute is an autonomous institute of Government of Karnataka which is located chikkamagaluru City with a population of more than one crore and has adequate clinical material for medical teaching and clinical facilities. It would cater the medical and health needs of the locals. It possesses the basic infrastructural facilities including a functional hospital to effectively manage and administer the college as well as the teaching hospital.

It is certified that:-

- a. The applicant have own hospital to utilize clinical facilities in the existing 400 bedded hospital witch is under the control of the Health and Family Welfare.
- b. It is desirable to establish a medical college in the public interest;
- c. Establishment of a medical college at Chikamagaluru by "Chikkamagaluru Institute of Medical Sciences, Chikkamagaluru" registered under Karnataka Socities Registration Act, 1960 is feasible. This institute is funded through 100% finance by the State Government as Grant-in-aid and the fee structure for students admitted in this institution is similar to other institutes run by Government Medical Colleges in Karnataka.
- d. Adequate clinical material as per the Medical Council of India norms is available.

It is further certified that in case the applicant fails to create infrastructure for the medical college as per MCI norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.
